2. Initial cost includes assessment of documentation suite and first engineer site visit, if subsequent visits / document reviews required will be charged per hour + mileage as required (£60 per hour, 50p per mile)

3. Companies applying for the approval, to supply suitable access to equipment (installed at a suitable indoor location) and any test vehicles / additional equipment as required.

\*\*\* Each model / Brand / product is to be certified annually (by original applicant) as still meeting DVSA specification and supported with Hardware, software and calibrations as required by the DVSA. Equipment that is not certified annual will be removed from the published DVSA list of current equipment,

**Note:** *To return a model back to the published current approved list after being removed will be charged at COC per year missed + administration cost of £40 + VAT. additional engineer assessment may also be required to confirm product does still meet DVSA requirements before being returned to published list.*
